The membership in PEMUDAH has gone through a refreshing change recently with the appointments of new PEMUDAH members from the Government and industry.

Three Secretary Generals have been appointed to PEMUDAH namely Dato' Sri Haji Mohammad bin Mentek, Ministry of Communications and Multimedia; Datuk Wira Dr. Noor Zari bin Hamat, Ministry of Tourism, Arts and Culture, and Dato' Haslina binti Abdul Hamid, Ministry of Agriculture and Food Industry.

PEMUDAH is co-chaired by YB Dato' Sri Mustapa Mohamed, Minister in the Prime Minister's Department (Economy), Tan Sri Dato' Seri Mohd Zuki bin Ali, Chief Secretary to the Government and captain of industry, Dato' Dr. Ir. Andy Seo Kian Haw.

YB Dato' Sri Mustapa Mohamed was confident that the inclusion of the new members with their extensive expertise, experience, and knowledge would strengthen PEMUDAH's function in building a more conducive business environment and efficient regulatory delivery.
